SCOPE OF THE MoU

- a. The budding graduates from the institutions could play a key role in technological up-gradation, innovation and competitiveness of an industry. Both parties believe that close co-operation between the two would be of major benefit to the student community to enhance their skills and knowledge through real time exposure to on-going projects through their various processes.
- b. **Curriculum Design:** Industry partner will give valuable inputs to the Academic partner in teaching / training methodology and suitably customize the curriculum so that the students fit into the industrial scenario meaningfully.
- c. **Industrial Training & Visits:** Industry and Institution interaction will give an insight in to the latest developments / requirements of the industries; the Industry partner to permit the Faculty and Students of the Department of Civil Engineering, School of Engineering, GU to visit its group companies and involve in Industrial Training Programs for the Industry. The industrial training and exposure provided to students and faculty through this association will build confidence and prepare the students to have a smooth transition from academic to working career. - k. There is no financial commitment on the part of the **GALGOTIAS UNIVERSITY**, the GU to take up any programme mentioned in the MoU. If there is any financial consideration, it will be dealt separately.

Nothing contained in this MOU shall, by express grant, implication, Estoppel or otherwise, create in either Party any right, title, interest, or license in or to the intellectual property (including but not limited to know-how, inventions, patents, copy rights and designs) of the other Party.


VALIDITY

This Agreement will be valid until it is expressly terminated by either Party on mutually agreed terms. Both Parties may terminate this MOU upon 30 calendar days' notice in writing. In the event of Termination, both parties have to discharge their obligations.


