Adv. Arjav Jain Advocate, Supreme Court of India

Mr. Jain had initiated his brief but impactful professional career from the Chambers of Mr. Pravir Kumar Jain, an Advocate on Record at Supreme Court of India, and has since been involved in corporate and individual litigation before the Hon'ble Supreme Court of India, Hon'ble Delhi High Court, Various Fora, Very recently, Mr. Jain has been part of the Advocates team in the case of *Jugal Kishore Khanna v. Sudhir Khanna* (2024), whereby the Supreme Court has pronounced a reportable landmark judgment in favor of his client, a feat achieved by very few at such an early stage of litigation career. The case goes down to the history of family-law litigations in India as it changes the jurisprudential aspects of these types of disputes.
