## GALGOTIAS UNIVERSITY UTTAR PRADESH POLICY FOR ALUMNI MEMBERS

## The Policy for Alumni Members shall be as follows:

To facilitate and encourage educational, social and cultural relations amongst the alumni of Galgotias University, Greater Noida with the aim of providing a common platform for the former members of the institution.

To bring the old students and alumni of Galgotias University under one forum for dissemination of knowledge and talents amongst its members, furtherance of fellowship, exchange of professional and personal experience, advancement of professional knowledge in general of the members of the Society.

To provide a forum for the interaction and exchange of views and ideas, between the members of the Society.

To foster a feeling of brotherhood, camaraderie and friendship and promote the spirit of mutual helpfulness amongst the members of the Society.

To enroll the members from time to time and keep them abreast with the activities of the Society and the University.

provide adequate avenues for drawing upon the knowledge and expertise of the alumni for furthering the cause of the University to attain an enviable position of distinction and influence in the academic, social and business world.

- To foster linkages amongst the alumni and to promote inter se, personal and friendly relations through interactive meetings and get-togethers.
- To collect, publish and disseminate information that is relevant to all the members of the Society.
- To play a significant role in the placement of students of the University in reputed organizations.
- To assist in arranging financial grants and other facilities to the needy students/alumni of the University.
- To highlight the achievements of the members of the Society as well as the current students of the University.
- To initiate, arrange, approve, support scholarships, freeships, grants and other assistance of any nature whatsoever to the meritorious students of the University.

To support any national/international cause that may bring laurels to the Society.

To undertake all such activities as are incidental or conducive to attainment of the above mentioned aims and objectives.

To receive and collect any gift, subscriptions and donations either in cash or in kind, or acquire by any other lawful means and spend the same in fulfilment of all or any of the aims and objects of the Society.

To acquire by purchase, take on lease, hire or by gift and hold any movable or immovable properties and any rights, or privileges that may be deemed necessary or useful for the advancement of the aims and objects of the Society.

The applicant for membership:

- should have attained the age of majority in accordance with Laws applicable in India.
- should be a graduate/post-graduate/M.Phil/Ph.D in any branch of studies offered by the University.
- should be of good moral character.
- should not be convicted for any criminal acts in the past.
- should have paid the requisite membership and other fees along with his written application form.
- should conform to any other qualifications laid down by the Executive Committee from time to time.
- Students who have been expelled from the Institute shall not be eligible to join the Society or continue as members.
- Membership can be terminated in case any member is found indulging in activities that are contrary to
  the interests of the Society, or any activity that brings the Society or the Institution into disrepute. The
  Executive Committee is empowered to take such action after securing sufficient proof of such activity.
  Such persons may be debarred from membership for a period of two to ten years or permanently
  depending on the nature of the offense.

The subscriptions for membership shall be as under:

Life membership Rs. 1000/-, this amount is to be paid once in the tenure. Fee shall be non-refundable An amount of Rs. 100/- may be added after every 2/3 years.
