### **Programme Structure:**

#### **Scheme of Papers:**

The One year - LL.M. shall have the following papers. (i). Foundation / Compulsory Papers (3 courses of 4 credits each)

(i) The Foundation/ Compulsory Papers consist of the following subjects, which should be completed in the first semester only.

- a) Legal Research Methodology (Comprehensive research both in theory and practical)
- b) Comparative Public Law
- c) Law and Justice in a Globalizing World
- (ii). Optional/ Specialization papers (6 courses of 3 credits each)
- (iii). Dissertation (8 credits)

The One-Year LL.M. program will consist of **42credits** in total. Each course corresponds to 60 and 45 hours of teaching for four and three credit courses respectively i.e. 15 classes for 1 credit.

#### Note:

- > Duration of examination of each paper shall be 3 hours.
- Each paper will be of 100 marks which will be scale down to 50 marksfor semester end examination and 50marks for internal assessment.
- Internal Assessment 1 (IA1)may be abook review, film commentary, abstract writing, case law analysis or empirical data analysis for 25 marks.
- Internal Assessment 2 (IA 2) may be course based project, research paper or research proposal for 25 marks.
- One Research Paper publication is mandatory compliance to obtain the LL.M. degree which will carry 2 credits and be evaluated outof total 25 Marks.
- Teaching Assistantship will be of 25 Marks restricted to total 5 classes for each student under the supervision of concerned supervisor. Teaching Assistantship will be of 2 credits
